Applications are open now and will close once all spots are filled. Only 206 Founders Members will be allowed.

2. **Membership Eligibility:**

Membership in The Bricks & Minifigs Fort Wayne, IN Founders Club is open to individuals at

least 18 years of age. Children 13 years to 17 years old can become Members with their parent or legal guardian's approval.

A valid name, address, phone and email address are required for sign up.

Membership is subject to approval by Bricks & Minifigs Fort Wayne, IN, and we reserve the right to refuse or terminate membership at our discretion.

3. **Membership Fees**

4. **Cancellation**

9. Membership dispute:

Any dispute, controversy, or claim, or counterclaim, other than a claim by Bricks and Minifigs for money due and owing, arising out of the store or relating in any way to this membership Agreement, Bricks & Minifigs and Members including their heirs and successors and assigns, or representatives, including without limitation the construction or validity, interpretation, enforceability or breach of this agreement shall be exclusively resolved by binding arbitration at the expense of the Member. The arbitration shall be conducted in Allen County, Indiana. The laws of the State of Indiana shall be applied in any arbitration proceedings, without regard to principles of conflict of laws.

10. Severability:

If any provision of this Agreement is deemed invalid, void, or for any other reason is unenforceable, that provision shall be deemed severable and shall not affect the validity and enforceability of the balance of this Membership Agreement.

11. **Loyalty Program

Loyalty program allows for a customer to receive up to \$6 in store credit for every \$100 spent.

Credit awarded at the time of current purchase is redeemable on the next purchase.

Customer can choose to not use existing credit at time of purchase which will allow credit to accumulate.

Credit can accumulate up to a max limit of \$60 dollars.

Credit accumulation resumes once the existing credit amount is under \$60 dollars and will continue to accumulate until it reaches the max limit of \$60 dollars.

Credit is valid at the Bricks & Minifigs Fort Wayne Location only. Located at 1728 Apple Glen Boulevard, Fort Wayne, IN 46804.

Credit is valid until the end of the current calendar year.

Loyalty program is a separate program open to anyone.

More than 1 member of a household is eligible to sign up for the loyalty program.

Loyalty program is free to sign up.
